TERMS OF USE FOR AEDES SOFTWARE

These terms are included in the end-user license agreement shipped with the purchased software. PLEASE READ CAREFULLY THIS DOCUMENT AND SIGN IT TO COMPLETE YOUR ORDER. PURCHASING THE SOFTWARE IMPLIES COMPLETE ACCEPTANCE OF THESE TERMS.

GRANT OF LICENSE. AEDES grants to Licensee the right to use on a single computer one (1) copy of the software product for each one license purchased (hereinafter referred to as the "Software"). The user license is associated to the Aedes Hardware License Key enabled through passwords.

COPYRIGHT. The Software is owned by AEDES and is protected by copyright laws and international treaty provisions. Therefore, Licensee must treat the Software like any other copyrighted material except that Licensee may either make one (1) copy of the Software solely for backup or archival purposes, or transfer the Software to a single hard disk, provided Licensee keeps the original solely for backup or archival purposes. Licensee may not in any case copy the written materials accompanying the Software, nor transfer to third party any material covered by copyright (e.g. the hardware license key).

SOFTWARE UPDATES, TECHNICAL SUPPORT, PROFESSIONAL CONSULTANCY. "Software Updates" means purchases of later versions of the software. "Technical support" means answering to technical questions related to the use of the software. "Professional Consultancy" means the provision of specific professional consultancy on the topics addressed by the Software Updates, Technical Support and Professional Consultancy are not included in these agreement: AEDES provides the Software with setup guide attached and/or included in the Software itself. In any case it is assumed that the Licensee has basic knowledge of the professional topics the Software deals with and is able to use the operative system the Software has been designed for. AEDES is entitled to provide Updates and Technical Support at an additional cost with the modalities given in the material attached to the Software and/or by direct contact. Such services are optional and independent, although subordinated to the acceptance of this license agreement. Professional Consultancy may be provided by AEDES consultants based on agreements concluded directly with them.

PROVISION OF ADDITIONAL LICENSES. Further licenses of the Software, in addition to the one object of this agreement, may be provided by AEDES based on the commercial conditions given elsewhere. In any case the Licensee must own a number of licenses equal to the number of copies of the Software installed on his hardware. As stated before, this license agreement refers exclusively to one (1) copy of the Software. If the Licensee owns more than one License the yearly renewal of Updates and Technical Support for each software follows the priority given by the License number.

FURTHER RESTRICTIONS. AEDES grants to Licensee a nonexclusive and nontransferable License to use this Software. The License may be transferred only in case of change in the company name of the Licensee and after communication to AEDES and authorization by AEDES. Licensee shall not sell, rent or lend the Software to others. Licensee shall not convert, decode, decompile or disassemble the Software. The License does not include the possibility to obtain the source code of the Software nor its design documentation.

USE OF LATER VERSION OF THE SAME SOFTWARE. Later version of the Software obtained through progressive upgrades may be all installed and operative but shall not be used simultaneously. In fact, the user license allows the use only of one version at a time.

LIMITED WARRANTY. Limited Software Warranty: The Software is provided "as is" with no warranties of any kind. AEDES does not warrant the Software nor the accompanying written material as regard their correctness and reliability. Verification of the Software suitability to achieve certain results, its installation, use and management are exclusive burden and responsibility of the Licensee. AEDES does not warrant that the Software functions meet the needs of the Licensee nor the Software will work in all the hardware and software combinations and, in particular, for all the operating system the Licensee may use. AEDES does not warrant the Software performances when used in a network, since the typology and configuration of the network may affect its performances. Limited Support Warranty: AEDES warrants that the CD and eventual hardware keys provided with the Software are free from defects in material and workmanship under normal use for a period of thirty (30) days from date of shipment. AEDES, of his own will, may replace the supports which are not covered by the warranty aforementioned, provided that they were regularly purchased and returned to AEDES. Limited Warranty is void if failure of the Software has resulted from accident, abuse or misapplication.

THEFT OR LOSS OF HARDWARE LICENSE KEY. AEDES is not liable for the use of the informatic supports provided (CD, hardware license key). In case of loss or theft of the hardware license key, a complaint to the competent authorities is required. The complaint shall report the value of the Software associated to the hardware license key object of the complaint (according to the current price list). After having received the complaint, AEDES will evaluate the replacement of the hardware key at a cost up to 50% of the list price of the licensed software.

NO LIABILITY FOR CONSEQUENTIAL DAMAGES. In no event shall AEDES be liable for any damages whatsoever (including, without limitation, damages for loss of business profits, business interruption, loss of business information, or other pecuniary loss) arising out of the use of or inability to use this AEDES product, even if AEDES has been advised of the possibility of such damages. In any case AEDES liability under this agreement is limited to an amount equal to the one paid for the purchase of the Software. All the expenses sustained by AEDES will be accounted in the application of the aforementioned liability limit.

THIS AGREEMENT SHALL BE GOVERNED BY THE ITALIAN LAW.
